STATUS	DEFINITION
No Digi ID System	There is no digital ID or mobile driver's license program or legislation in your state.
<ul><li>Deactivated Digi ID</li><li>System</li></ul>	A digital ID or mobile driver's license program was launched in your state, but then it was deactivated. This typically happens because the cost or performance of the related software was unsatisfactory to the government.
Exploratory or Pre- Launch	There has been news or supportive legislation in your state to launch or pilot a digital ID or mobile driver's license program in your state. This is the broadest category with some states having a press conference about mDLs to others having enacted laws.
Launched - Some/Minimal Protections	Your state has launched a digital ID or mobile driver's license program or pilot in your state that includes some protections. This includes states with a wide range of protections including references to related privacy laws (CA, IL) or active bills supporting selective disclosure or identifying information. For this guide, "minimal protections" at the most means protecting the ability to still use a physical ID and in some instances from police access to your phone.

Launched - No Law

Your state has launched a digital ID or mobile driver's

license program or pilot in your state that has no

supportive legislation guaranteeing you protections.

- Stay abreast of any Digital ID System inklings in your local government and use the resources on our website to reach out to your community, reach out to elected officials, and testify in public hearings about how digital ID systems will impact your community.
- Any state that does not adopt a Digital ID System protects us all from complete nationwide coverage-thank you for holding the line!
